Update on NC-SARA Progress, Projects, and Strategic Plan

NC-SARA's Interim President and staff shared updates on the following six areas of core work:

Update from Regional Compacts and Regional Steering Committee Chairs on SARA

- The NC-SARA Board discussed draft bylaw changes regarding the role of the board secretary and alignment of the bylaws with the new SARA Policy Modification Process.
