

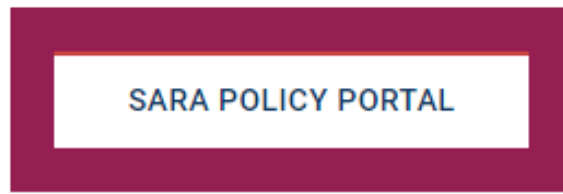


Instructions for Viewing SARA Policy Modification Proposals from Past Years
